Reading aloud from the recently released announcement, dated February 2018, Lawler further noted that

 - a school-based enterprise is an entrepreneurial operation in a school setting that provides foods and services to meet the needs of the market
 - certification is at three different levels, silver, bronze and gold, with gold being the highest
